### Course Description

This qualification reflects the role of workers who provide self-directed recovery oriented support for people affected by mental illness and psychiatric disability. Work involves implementing community based programs and activities focusing on mental health, mental illness and psychiatric disability. Work is undertaken in a range of community contexts such as community based non-government organisations; home based outreach; centre-based programs; respite care; residential services, rehabilitation programs; clinical settings; or supporting people in employment.

### Entry Requirements

No licensing, legislative or certification requirements apply to this qualification. However, Kimberley Aboriginal Medical Services requires entrants to be 18 years of age and provide a certified copy or original of photo ID.

### Work Placement

To achieve this qualification, the candidate must have completed **at least** 80 hours of work as detailed in the Assessment Requirements of units of competency. KAMS however, will endeavour to place students for around four weeks if able. Generally, candidates will require a criminal history check depending on location of work placement.

## Delivery

CHC43315 – Certificate IV in Mental Health will be delivered over a period of up to 10 months which consists of 6 two week blocks and 1 three week block of face to face delivery and approximately four weeks of work placement.
